## Overview of BCTEA

The 2018 [BC Tripartite Education Agreement: Supporting First Nation Student Success \(BCTEA\)](#), signed by the BC First Nations Education Steering Committee (FNEESC), Canada, and British Columbia, and witnessed in support of the execution of the agreement by the BC First Nations Schools Association (FNSEA), is intended to promote systemic shifts and collective efforts that will support improved educational outcomes of all First Nation students in British Columbia (BC), regardless of where they live or are enrolled in school.

## Evaluation of the Effectiveness of FNEESC Programs and Services

FNEESC is pleased to announce that a Request for Proposals (RFP) has been released for an evaluation of the efficiency and effectiveness of programs and services delivered by FNEESC. FNEESC's Board of Directors has established an Evaluation Committee to provide guidance, advice and direction for this project.

FNEESC looks forward to identifying a qualified consultant to review FNEESC's operations and work with First Nation communities and schools in order to identify strengths, gaps, weaknesses or deficiencies in the delivery of programs and services, and to highlight relevant recommendations for improvement.

The FNEESC Board of Directors perceives the evaluation as a key component of our organization's accountability to First Nations in BC, as well as a meaningful way to inform our program planning.

The evaluation will involve a document review, interviews with key informants, and some site visits. The Evaluation consultants will also be asked to implement surveys of First Nations community, school and partner group representatives. We welcome all input and hope that you will respond to the evaluation surveys and requests for feedback.

The RFP has been [posted to the FNEESC website](#) and it has also been posted on RFP.ca and bidscanada.com. The FNEESC Evaluation Committee will select the qualified consultants following the submission deadline of November 23rd, and it is expected that the consultants will begin the evaluation in January 2019. Copies of the RFP are available to anyone interested upon request.
