Duties and Responsibilities

Direct School Support

Travel regularly to participating schools to work with First Nations language teachers to support effective implementation of First Nations language programs.

Program Management & Implementation: First Nations Schools Language Essential Outcome Project

The First Nations Language Coach is responsible for supporting effective implementation of First Nations Language Essentials in First Nation schools. This work involves the following duties and activities:

- Coach language teachers in First Nation schools in lesson delivery for the implementation of the essential learning outcomes;
- Coach language teachers in the use of effective teaching strategies and formative assessment techniques in order to track student learning;
- Assist, where possible, in strategies for translating the curriculum materials to meet each school's needs;
- Facilitate collaboration among language teachers to share strategies for tracking achievement of the essential learning outcomes; and provide continued support through email, video coaching, and telephone communications with the schools.

Indirect Services

- As directed, provide additional professional development to First Nations school professionals through presentations and workshops at conferences and meetings.
- Participate in meetings as a member of the Instructional Services team.
- Research new trends and promising practices in the field of First Nations languages.
