- 2. Avoid using special characters when referring to cost or amounts in the Expenses section. They can sometimes interfere with the coding of math calculations, causing errors or misinterpretations.

  3. Note: The "Save & Continue" is a feature in Alchemer that allows respondents to save & continue all the form progress up to that point is saved (including on the active page). Find this feature after the first page in the top-right of the second page, and proceed to enter your professional email address(only), within 5 minutes you will receive a link to return to your Proposal later.

- 2. Before completing the proposal, review the following documents:

  - Skills Link Suggested Activities Resource
  - Always note the proposal submission deadline/reporting deadlines.
- 3. When you're ready to fill out the proposal, follow the prompts and complete each section as required.

Please kindly note: If you require additional activity pages, please reach out to <a href="mailto:soniao@fnesc.ca">soniao@fnesc.ca</a> – for example, due to software limitation, the form will only allow you to fill out max. 10 Mentored Work Placements.

- 4. When entering numbers, please do not enter special characters such as \$ dollar sign only enter actual numbers.
- 5. When entering, form will calculate totals per activity and per placement. That being said, you will need to calculate the sub total of your overall proposal. For example, if you have three Science and Tech activities you'll need to add up the total of each of the three science and tech's to calculate and enter the sub total amount of your program.
- 6. Submit the form: Once you are satisfied that the form is complete and accurate, submit via submission button on final page. You should receive a confirmation message or email that the form has been submitted successfully and you'll receive a pdf. copy of your workplan.
